<b>LEVEL 1: IN-PERSON Implementation Assessment with 6-month follow-up</b>	\$8500 (ZS) \$10,000 (TIC)	\$13,000(ZS) \$16,000 (TIC)	Includes on-site implementation assessment, facilitated discussions, customized staff web survey and report, analysis/scoring, and final report which includes data presentation and recommendations. If needed/requested, earlier assessments will be rescored to be in alignment with new tool. Cost includes a follow-up at 6 months. TIC option includes in-person Trauma Informed Care Training & consultation from Trauma Informed Oregon.
<b>LEVEL 2: VIRTUAL Implementation Assessment with 6-month follow-up</b>	\$5,000 (ZS) \$6,000 (TIC)	\$6,500 (ZS) \$8,000 (TIC)	Includes virtual facilitated discussions, customized staff web survey and report, analysis/scoring, and final report which includes data presentation and recommendations. If needed/requested, earlier assessments will be rescored to be in alignment with new tool. Cost includes a follow-up at 6 months. TIC option includes virtual Trauma Informed Care Training & consultation from Trauma Informed Oregon.
<b>LEVEL 3: ORGANIZATIONAL SELF-ASSESSMENT with TIO training &amp; I-Lab Consultation.</b>	\$2,500 (ZS) \$3,500 (TIC)	\$3,500 (ZS) \$4,500 (TIC)	Includes virtual TIC training workshop, facilitated discussions, data translation/prioritization/assessment, and final report which includes data presentation and recommendations. Does not include consumer based web surveys or 6-month follow-up assessment.

<b>Additional In-person Follow-Up Assessment</b>	\$ 3,500	\$ 6,500	One in-person follow-up assessment and report
<b>Additional Virtual Follow-Up Assessment</b>	\$ 2,000	\$ 3,500	One virtual follow-up assessment and report.
<b>Additional Service - Consumer-Based Web Surveys</b>	\$ 700	\$ 1,050	Administration of one Zero Suicide or Trauma Informed Care self-assessment web survey and accompanying report
